The mother was walking Jordan over to the father's home, someone offered her a ride and asked for a sexual favor in exchange for money from the mother. She performed the sexual favor while Jordan was in the back seat. The driver asked the mother for another sexual favor and she denied. He hit her over the head with a mason jar full of weed and physically assaulted her. She did not know him at all. She woke up in a park in Largo; her son and the drivers whereabouts are unknown.

The mother is unemployed. She worked in a restaurant and got fired because she had to watch Jordan and had no one to babysit him. The mother is upset and currently pregnant with another child. The mother cut herself in the past, but is not taking medicine for it. The mother's mental health is unknown.

Jordan just came out of DCF custody, the mother was able to get him back on Friday. He was taken away initially because the father is a drug dealer and gang member.

On this night it was reported that the father was arrested by the Largo Police Department on July 15th, 2018, after the mother alleged that he battered her. The specific details surrounding the incident are not known. According to the father he and the mother are not getting along and dad wants out of the relationship and the parents had discussed the custody of the child and on the 15th, dad went to pick up Jordan and mom refused to let dad see him and the two got into an argument over the situation however dad alleged that the mother called the police on him and falsely accused him of battering him.
