**PETITIONER'S SUPPLEMENTAL REPLY TO RESPONDENTS'**  
**RESPONSE TO ORDER TO SHOW CAUSE**

Petitioner, through counsel, files this Supplemental Reply to Respondents' Response to Order to Show Cause.

1. On the afternoon of Monday, March 13, 2017, numerous text messages were produced by the PTC that were responsive to the initial public records from June 2016. *See* Composite Exhibit 1, attached hereto.

2. The text messages appear to originate from the cell phone of former PTC Board member Victor Crist,<sup>1</sup> and contain messages sent and received from Kyle Cockream, Kyle Parks, Matthew Blair, and others.

3. Mr. Crist previously produced a small number of text messages, some of which were attached as Exhibit B in the written report by attorney David Smith filed with the Court last Tuesday, March 7, 2017. No explanation has been provided as to why the text messages belatedly produced by Mr. Crist were not previously provided.

4. The production of these messages is expressly contrary to the PTC's representation in its Response to the Order to Show Cause, including sworn affidavits, that the PTC has "fully and timely" responded to Petitioner's public records request. *See* PTC's Response at 5; Affidavit of Cynthia Oster at ¶ 4.<sup>2</sup>

5. Abundant evidence now exists which demonstrates that the PTC is playing "fast and loose" with the Public Records Act, for which additional discovery is appropriate. *See Lorei v. Smith*, 464 So. 2d 1330, 1333 (Fla. 2d DCA 1985). *See also Competitive Enter. Inst. v. Office of Sci. & Tech. Policy*, 185 F. Supp. 3d 26, 27 (D.D.C. 2016) (discovery in FOIA case proper where agency's representations about scope and completeness of search for responsive records "have been, to say the least, inconsistent."); *Judicial Watch, Inc v. Dep't of State*, CV 14-1242 (RCL), 2016 WL 1270980, at \*1 (D.D.C. Mar. 29, 2016) (discovery proper in FOIA case based upon "constantly shifting admissions by the Government and the former government officials").

6. First, it was the PTC's Executive Director—now under criminal investigation by FDLE—who wiped clean electronic devices and used a software program to surgically delete text messages. Now it is the PTC's former chair who inexplicably produces hundreds of responsive records long after he was put on notice by the agency attorney to preserve and produce those records.

7. The PTC has now had 9 months to identify and produce records responsive to the initial records request. Despite the filing of this lawsuit and the issuance of two orders to show cause, the PTC, through its board members and staff, is openly flaunting the Public Records Act with impunity and thwarting Petitioner's constitutional right to obtain access to public records.

<sup>2</sup> Petitioner commends PTC's counsel for providing the additional records responsive to the records requests and in no way suggests that the PTC's counsel was aware of the undisclosed text messages.

Immediate action is required to get tough on the PTC by imposing sanctions, including exercising contempt powers, to prevent the PTC from making a mockery of the Public Records Act.

8. Petitioner requests that the Court enter an Order scheduling a hearing and requiring each of the PTC's board and staff members, past and present, to file affidavits which answer and describe with specificity the following information:

- i. during your tenure as a board or staff member of the PTC, how did you manage and preserve text messages sent or received in the course of conducting official PTC business, and what, if anything, did you do to make those text messages available to the PTC for conducting searches in response to requests under the Public Records Act;
- ii. what, if any, efforts did you make to inform the PTC records management personnel about your use of text messaging to conduct official agency business?
- iii. what, if any, efforts did you make to identify all electronic devices and accounts that contain records responsive to the record requests attached as Exhibit 1 and Composite Exhibit 2 to the Amended Petition for Writ of Mandamus;
- iv. what, if any, efforts did you make to search for and retrieve all records responsive to the records requests attached as Exhibit 1 and Composite Exhibit 2 to the Amended Petition for Writ of Mandamus;
- v. what, if any, efforts did you make to preserve all records responsive to the records requests attached as Exhibit 1 and Composite Exhibit 2 to the Amended Petition for Writ of Mandamus;
- vi. whether any records potentially responsive to the records requests attached as Exhibit 1 and Composite Exhibit 2 to the Amended Petition for Writ of Mandamus may have been deleted and, if so, what efforts have been made to obtain those records from other sources or to notify agency personnel that such records are not in your possession.

9. Additionally, Petitioner seeks to take the depositions of the following individuals: Victor Crist, Al Higginbotham, David Pogolirich, Dwayne Denny, Brett Saunders, Kyle Parks, and Kimberly Kerwin.
